Photo Previews (downsized, unedited images) will be available for viewing within 7-14 days from the day, full payment was received. Please note, that previews are for viewing only! None of the previews can be downloaded or posted online. Fully edited high-resolution digital images will be delivered within 7-14 days from the day, images were picked by the client from the preview gallery. Price per each additional photo (if available) is \$_____. Other services as prints and albums are available for extra cost.
